We are pleased to inform you that the ICAR proposes to fill-up one position of **ICAR Norman Borlaug Chair in International Agriculture in ICAR-AU system**, under the **Scheme of Creation of National Professorial Chairs**. The basic objective of the Scheme is to promote excellence by recognizing outstanding scientists with proven output and outcome for creating a culture of basic research through their project work in the National Agricultural Research System (NARS) and establishing and nurturing a novel school of thought around the recognized person.

The position carries a fixed pay of ₹ 75,000/- per month with allowances for a period of five years. The tenure of the position may be extended, based on excellence shown in the quality of work, but in no case beyond the age of 65 years of the incumbent. In addition, the contingent funds for required staff, equipment and operational assistance would also be provided by the ICAR.

Nationally and Internationally acclaimed scientists not below the rank of Principal Scientists/ Professors active in research, holding the post for a minimum period of 8 years, and not exceeding 58 years of age (as on **20<sup>th</sup> October, 2014**) who have demonstrated individual excellence/achievements and significantly contributed through research having impact on International Agriculture with **strong evidence** of contribution to the research in the form of knowledge and technology generation including published work in reputed peer reviewed high impact journals, innovation as product/process/ methodology developed/patented/protected with **relevance for International Agriculture** are eligible for consideration for award of this Chair (visit ICAR Website: <http://www.icar.org.in/> for Guidelines of ICAR National Professorial Chairs).

I take this opportunity in requesting you to **kindly nominate such eminent scientist(s)** along with **up-to-date bio-data and the research project proposal** in the prescribed proforma (Parts A, B and C) for consideration by the Search-cum-Selection Committee. The nominations may please be forwarded so as to reach to the undersigned **latest by 20<sup>th</sup> October, 2014**. Those who have been nominated in response to the earlier ICAR notification number F. No. 27(2)/NP/2013-HRD dated 21<sup>st</sup> March, 2013 for ICAR Norman Borlaug Chair in International Agriculture need not be nominated again unless the technical programme is proposed to be changed. **Nominations received after the due date will not be considered**. The prescribed proforma for nomination is enclosed and can also be downloaded from ICAR website. It may please be noted that canvassing of any kind will be treated as disqualification.

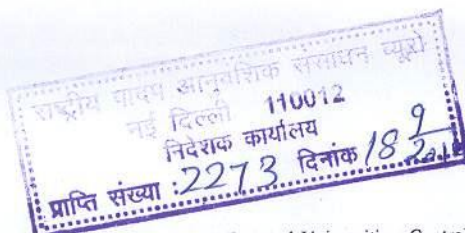
