Sub: Limited Quotation for Purchase of Liquid Nitrogen Gas.

Sir,

We want to purchase Liquid Nitrogen for our Bureau as per terms and conditions mentioned below:-

- The annual requirement of LN is approximately 70,000 lits. Which would be needed to be supplied to NBPGR, in parts.
- The LN station (5,000 lits capacity) is available at NBPGR, campus and is to be filled whenever required. Capacity for filling of LN in station (about 4000 lits each time) may be mentioned.
- Rates for supply of LN to NBPGR in 180 liters or higher capacity pressurized vessels of suppliers may also be mentioned.
- Rates of LN if NBPGR transports it from the suppliers premises in Delhi or NCR may also be mentioned.
- 5. Rates may be quoted for cost of LN with Excise duty and sales tax indicated.
- 6. The supply will be needed to be made within 48 hr. of issue of order.
- Each tenderer should attach a satisfactory service certificate from their customers including that from NBPGR, if RC existed with NBPGR during the past 5 year.
- 8. Each tenderer will have to deposit Rs. 10,000/- as earnest money along with the tender in the form of demand draft drawn in favour of Director, NBPGR, New Delhi.
- Payment will be made to the address at which Rate Contract will be given which should be mentioned on the bill.
- No. Sale Tax Form "C" or "D" will be issued from NBPGR.
- 11. The Director, NBPGR, New Delhi reserves the right to disqualify/ cancel all or any of the tenders without assigning reason thereof.
- 12. The decision of the Director, NBPGR, New Delhi, shall be binding on all issues relating to tender.
- 13. As per the decision of the Council the payment will be made through Electronic transfer, so provide the following Bank Details:-

1. IFSC Code, 2. Account No. 3. Name of Bank and its Branch

You are requested to please send your quotation with rates as asked above (item nos. 2, 3, and 4) in a tabular form, to the undersigned latest by 20.07.20115 upto 02.30 PM duly marked as Purchase of Liquid Nitrogen Gas of on the cover, which should be wax sealed. The rate should be effective for at least one year and be quoted in precisely the same unit as required, for non-compliance of the terms, the quotations are liable to be rejected. The quotations may be sent by Registered Post or put in QUOTATION BOX kept in the Main Gate No. 2, NBPGR, New Delhi Bureau's office for this purpose. The envelop in which the quotation is sent should clearly superscribe the item for which the quotation relates i.e. the letter No. & date.
