Sir,


The ICAR vide its letter No. 8 (1)/2007-Per.IV dated 26th April, 2012 has issued the revised model qualifications for selection of Scientists and Research Managers in the ICAR on lateral entry basis. The existing essential qualifications for the posts of the DDGs/Director, NAARM/ND, NAIP (Sl. No.7) and Directors of National Institutes with Deemed to be University status (Sl. No.8) have been considered in totality at ICAR and decided with the approval of 234th meeting of GB, ICAR dated 26.6.2015 as under:

The experience in both of the positions, i.e., RMPs and HOD/PC/ZC/JD shall be considered as mutually inclusive and not mutually exclusive. In such cases a weightage of 0.6 be given for service rendered as Heads of Divisions of ICAR Institutes/Heads of Regional Stations of ICAR Institutes/Project Coordinator/ Zonal Coordinator (service rendered prior to 27.01.2009)/Joint Directors of institutes other than National Institutes/Deemed Universities and a weightage of 1.0 be given for service rendered in the Research Management Positions and the experience gained in two categories of posts shall be added to fulfil a requirement of three year. The service in both the capacities will be considered for the purpose of eligibility for selection to the positions of ODG/Director, NAARM/ND, NAIP/Directors of National Institutes with deemed to be University status.

Accordingly, the existing essential qualifications for the posts of the DDGs/Director, NAARM/ND, NAIP (Sl. No.7) and Directors of National Institutes with

Deemed to be University status (Si. No.8) notified vide Council's letter No.8(1)/2007-Per.IV dated 26th April,2012 stands amended to the above extent. All the other stipulations in regard to above mentioned essential qualifications will remain the same.

The amended qualifications will be effective on the posts advertised after the date of issue of this order.
