# The following terms and conditions to be adhered while submitting the quotations:

- 1. The amount of bid security (Earnest Money) should be deposited as Rs. 2000/- in the form of Account Payee Demand Draft from any of the Commercial Banks in favour of the Director, National Bureau of Plant Genetic Resources, New Delhi, payable at New Delhi
- 2. Bid security should remain valid for a minimum period of 90 days beyond the final bid validity period.
- Sale Tax/ other levies to be charged should be specifically indicated, failing which the 3. quotation will not be entertained.
- Incomplete bids are liable to be ignored. 4.
- The Director, NBPGR, New Delhi, reserves the right to disqualify/ cancel all or any 5. of the tenders without assigning reason thereof.
- 6. The decision of the Director, NBPGR, New Delhi, shall be binding on all issues relating to tender.
- 7. Authorized dealership certificate should be enclosed alongwith the quotation.
- Compliance statement in tabular form giving details as per specifications given in the tender documents, Do NOT copy paste specification
- 9. Literature in support of compliance statement (supply original brochures, avoid photocopies).
- 10. Conditions of advances payment before the supply and satisfactory installation of the machine are NOT ACCEPTABLE.
- 11. Bidder should not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
- 12. The supply of material will have to be completed within 4-6 weeks from the date of Issuing/Purchase order. In case of any delay in executing the contract, the supplier-

Shall promptly inform the purchaser in writing, the fact of delay and duration of supply before the expiry of the delivery period. Otherwise liquidated damage @ 0.5% per week of the cost of purchase order will be deducted subject to a maximum of 10%.
