- 5. Compliance statement in tabular form giving details as per specifications given in the tender documents, Do NOT copy paste specification
- 6. Conditions of advances payment before the supply and satisfactory installation of the machine are NOT ACCEPTABLE.
- 7. Bidder should not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
