

The following terms and conditions to be adhered while submitting the quotations:

1. Sale Tax/ other levies to be charged should be specifically indicated, failing which the quotation will not be entertained.
2. Incomplete bids are liable to be ignored.
3. The Director, NBPGR, New Delhi, reserves the right to disqualify/ cancel all or any of the tenders without assigning reason thereof.
4. The decision of the Director, NBPGR, New Delhi, shall be binding on all issues relating to tender.
5. Compliance statement in tabular form giving details as per specifications given in the tender documents, **Do NOT** copy paste specification
6. Conditions of advances payment before the supply and satisfactory installation of the machine are **NOT ACCEPTABLE.**
7. Bidder should not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
8. The supply of material will have to be completed within 4-6 weeks from the date of Issuing/ Purchase order. In case of any delay in executing the contract, the supplier- Shall promptly inform the purchaser in writing, the fact of delay and duration of supply before the expiry of the delivery period. Otherwise liquidated damage @ 0.5% per week of the cost of purchase order will be deducted subject to a maximum of 10%.
