Additional Notes:

- Processing fee would be chargeable for the rejected samples also as per their category/ plant type.
- In the event of grant of relaxation by the Competent Authority [in respect of Phytosanitary Certificate and/ or Clause 9 (2)], the consignment will be released to the indenter after levying five times the normal fee [Plant Quarantine (Regulation of Import into India) Order 2003 Chapter VI Clause 14(2)].
- Fee for the material received from DPPQS, Faridabad and its regional stations:
- Pest identification (fungi, bacteria, insect, nematode and weed) = Rs 500/- per sample.
- Quarantine processing including grow-out test for virus= Rs.1000/ per sample.
- In the event of the indenter not taking material after quarantine processing due to their own justified reasons and request for incineration by ICAR-NBPGR, five times the normal processing fee would be levied. If case they do not pay the required penalty, the indenting firm/organization would not be allowed for further import till the existing dues are cleared.
