Sub: Revision of Pension/Family pension in terms of 7th Central Pay Commission in respect of ICAR Pensioners/Family pensioners - reg.

Sir,

In pursuance of ICAR letter No. GAC-21-32/2017-CDN dated 30.08.2017 & FIN/10/02/2017-Pension dated 31.08.2017 (**copy enclosed**), I have been directed to inform that the Competent Authority/Council has extended the pensionary benefit of 7th CPC for revision of pension/family pension of the Council's pensioners/family pensioners in respect of pre-2016 and those having retired/died in harness after 01.01.2016 and up to implementation of 7th CPC in the Council in accordance with the instructions issued by the GOI vide O.M. No. 38/37/2016-P&PW(A)(ii) dated 04.08.2016 (**copy enclosed**).

Accordingly, it is requested that revision of pension/family pension of the existing pensioners/family pensioners pertaining to ICAR-NBPGR unit may kindly be carried out in terms of Para No. 4.1 & 5 of the enclosed O.M. No. 38/37/2016-P&PW(A)(ii) dated 04.08.2016 by the Bank. The Revised pension is to be determined by multiplying the existing basic pension/family pension by 2.57. The amount of revised pension/family pension so arrived at shall be rounded off to next higher rupee.

The payment of revised pension/family pension along with revised dearness relief may be made by the Bank w.e.f. August,2017 onwards.

Further, orders for payment of arrears on account of revision of pension/family pension for the period 01.01.2016 to 31.07.2017 will be issued separately.
