No. 38/37/2016-P&PW(A)(ii) dated 04.08.2016 (copy enclosed).

Accordingly, it is requested that revision of pension/family pension of the existing pensioners/family pensioners pertaining to ICAR-NBPGR unit may kindly be carried out in terms of Para No. 4.1 & 5 of the enclosed Q.M. No. 38/37/2016-P&PW(A)(ii) dated 04.08.2016 by the Bank. The Revised pension is to be determined by multiplying the existing basic pension/family pension by 2.57. The amount of revised pension/family pension so arrived at shall be rounded off to next higher rupee.

The payment of revised pension/family pension along with revised dearness relief may be made by the Bank w.e.f. August,2017 onwards.

Further, orders for payment of arrears on account of revision of pension/family pension for the period 01.01.2016 to 31.07.2017 will be issued separately.
