OFFICE ORDER

In pursuance of Council's letter number CS/16/1/2015-IA.IV dated 22th May, 2018, approval of the Competent Authority has been conveyed on item No. 1 of Supplementary agenda of 43rd meeting of the IMC of ICAR-NBPGR, New Delhi regarding enhancement of processing fees for various mandated activities of the Bureau. The detailed revised fees/ charges for different activities are as follows:

Revised fees for issuance of import permit, handling and quarantine processing for germplasm, transgenic and international trial samples to be imported by public and private sector for research

(A) Processing fee (Rs.) applicable for issuance of Import permit

Additional Notes:

- Processing fee would be chargeable for the rejected samples also as per their category/ plant type.
- In the event of grant of relaxation by the Competent Authority [in respect of Phytosanitary Certificate and /or Clause 9(2)], the consignment will be released to the indenter after levying five times the normal fee [Plant Quarantine (Regulation of Import into India) Order 2003 Chapter VI Clause 14 (2)]
- Fees for the material received from DPPQS, Faridabad and its regional stations:
 - Pest identification (fungi, bacteria, insect, nematode and weed)= Rs 500/- per sample.
 - Quarantine processing including grow-out test for virus = Rs. 1000/- per sample.
- In the event of the indenter not taking materials after quarantine processing due to their own justified reasons and request for incineration by ICAR-NBPGR, five times the normal processing fee would be levied. If case they do not pay the required penalty, the indenting firm/organization would not be allowed for further import till the existing dues are cleared.
