TENDER DOCUMENT

Terms and conditions:

1. The bidders can inspect unserviceable old condemned store articles during office hours lying in the shed of NBPGR old building and new building at this Bureau between **2:30 PM to 4:30 PM**, after contacting the Store Officer or Store Keeper.
2. Tender forms may be down loaded from the CPP Portal or Bureau's website: www.nbgpr.ernet.in
3. The auction will be done on the basis of where it is as it is.
4. EMD of Rs. 10,000/- (Rupees Ten Thousand Only) by way of Account payees DD/Bankers Cheque/FDR/or BG form any of the commercial Bank in favour of the Director, ICAR-NBPGR, payable at New Delhi, is to be attached with tender/auction bid.
5. 25% of the total value of auction will be deposited by the successful bidder within a period of one day, other –wise EMD will be forfeited.
 - d) The bids should be signed by bidder himself/themselves or a person duly authorized.
 - e) Bid document are not transferable.
 - f) Overwriting or alternations will also disqualify the bid unless these are legible attested by bidder/bidders.
6. The sealed auction bids should be dropped in the tender box kept at Gate No.2 NBPGR, New Building super- scribed with the words "**Quotation for condemned stores material**".
7. The auction bids not fulfilling the above norms will be summarily rejected without assigning any further reasons.
8. Auction bids received after the due date will be rejected.
9. The sealed auction bids will be opened on 19/11/18 at **2:00 PM** in presence of all bidders or their authorized representatives in NBPGR (New Building) Committee Room, New Delhi. In case the above date happens to be a holiday or inconvenient for other reasons, the same will be carried out on the next working day.
10. Those tenders found unsigned by the bidders and incomplete for other reasons are liable to be rejected.
11. During opening the auction bids, only the person who has signed the application will be allowed to participate. The signatory may authorize his official with proper authorization letter. No mobile phone calls will be permitted during the opening of the auction bid.
12. The auction bids in sealed covers shall be opened by the tender opening committee.
13. The EMDs of the unsuccessful bidders will be retained until confirmation of the successful bid and the same will be released only after the confirmation.
14. The successful buyer shall pay the bid amount within Three days from the date of confirmation of the tender/auction. All payments are to be made in Indian rupees in the form of account payee demand draft drawn in favor of the Director, NBPGR only.

15. As soon as the full amount of the bid money is paid by the successful buyer, he shall acquire lien on the auctioned equipment/furniture and its safety from any damage or pilferage, fire, or any other unforeseen calamity will be his duty/ responsibility and no claim whatsoever on this account shall be entertained by the seller.
16. The buyer shall remove the items within 15 days from the date of confirmation.
17. Once the successful auction bid is awarded by the office, he will be solely responsible for the dismantle on any item auctioned; loading/unloading and transportation of entire lot items. The office will not bear any cost towards this.
18. Any damage to the Institutes property during the shifting or removing of the items will be charged form the bidder.
19. In case any successful bidder fails to remit the bid money in full on the stipulated date, the Director, NBPGR shall be at liberty to forfeit the EMD. The tenderer will have no claim on such money forfeited.
20. The quantities and specification mentioned in the Annexure (name and quantity of items) are only approximate or indicative. The bidders shall satisfy themselves about the quantity, quality and conformance to specification etc. before quoting for such item.
21. The Director, NBPGR reserves the right to reject any or all the offers without assigning any reason whatsoever.
22. In case of dispute, the decision of the Director, NBPGR will be final and will be binding upon the bidder.
23. The GST & other levy if any will have to be paid extra by the successful bidder.
24. It will be presumed that the bidders before submitting the offer have read carefully all the terms & conditions and accepted the same in full. Deviation from the terms and conditions as given in this are not permitted. Any such condition bid and telegraphy bid is liable to be rejected and no alternation shall be allowed after bid is submitted. No counter terms and conditions shall be accepted.
25. All these conditions listed here shall be binding on the bidders and will sign all pages of this tender form.
26. The Scrap includes batteries & computers parts which are classified under hazardous items therefore prospective bidders of such lots of hazardous waste/scrap batteries/ e-waste should be in possession of registration, valid on the date of e-Auction and on the date of delivery, as recycler/pre-processor agency.


