**Terms & conditions :**

1.	The sealed quotations should be accompanied by Earnest Money Deposit (EMD) either in cash or Demand Draft drawn in favour of Officer in charge, NBPGR, Thrissur and should be submitted to the undersigned on or before 2.00 PM on 05/04/2019. The quotations will be opened at 3.00 PM on 05/04/2019. Late quotations or quotations without EMD will summarily be rejected.
3.	The successful bidder has to pay the entire amount within 3 days after approval, and take possession of the bamboo poles. The Poles should be removed from the campus within 15 days (Fifteen days) from the date of payment in full.
4.	The successful bidder has to remove the auctioned bamboo poles at his/her own cost and risk during office hours on working days only, and get a gate pass issued by the authorised officer, which has to be signed and surrendered in original to the security guard before taking the articles outside the campus, each time. However, removal process should not damage any of the trees /fence / other crops or any other property of the Station and should not hamper the routine activities of the station in any manner.
5.	If the successful bidder, whose bidding is accepted, refuses to pay the balance amount in full as per the bid amount within 3 days after approval, he/she will have to forfeit the EMD and the right over the auctioned article.
6.	This office will not take any responsibility for the safe custody of the poles sold through this tender notice to the bidder.
7.	Interested parties can visit the station / farm to have a first-hand assessment before submitting their quotation on any working day between 10.00 AM and 4.00 PM under prior intimation.
8.	Any tax / levies as per rules shall be payable by the successful bidder.
9.	The Officer in charge reserves the right to reject or accept any bid, even the highest without assigning any reason thereto and to modify any of the above conditions. The decision of the Officer in charge will be final in all matters.
