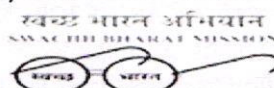

On behalf of the Director, ICAR-NBPGR, New Delhi, e-Quotations/tenders/Bids are invited from the registered firms & eligible contractors **on portal/online only** for supply of **Manpower i.e. Unskilled/ semiskilled/ Skilled etc. for field work, Lab work, agriculture work and office works i.e. Typing, photocopy, diary/despach etc. at ICAR-NBPGR, Regional Station Cuttack as per points/demand/requirement of the Bureau.** The Quotations/bids duly signed & completed in all respect should be submitted with scan documents online at CPPP **latest by 10.02.2020, 2.30 PM** The incomplete Quotations/bids will be treated as rejected.
2. The Tender form/bid documents may be downloaded from the <https://eprocure.gov.in/eprocure/app>. Online submission of Bids through Central Public Procurement Portal (<https://eprocure.gov.in/eprocure/app>) is mandatory. Manual/Offline bids shall not be accepted under any circumstances. However, for the purpose of realisation, the bidder has to send the Demand Draft ,FDR, banker's cheque or Bank Guarantee as EMD in original to this institute through post or by hand so as to reach before the date & time of closing of tender.
3. Tenderers/bidders are requested to visit the website <https://eprocure.gov.in/eprocure/app> regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
4. In case, any holiday is declared by the Government on the day of opening, the tenders will be opened on the next working day at the same time. The Director, ICAR-NBPGR, New Delhi reserves the right to accept or reject any or all the tenders.
5. The firms/contractors are required to **upload** copies of the following documents as per prescribed format **in pdf form:-**
  - 5.1 **Technical Bid**
    - a) Registration certificate of the firm under State/Central Govt. under Shop & Estt. Act. or any other act indicating date of inception.
    - b) Employee EPF registration certificate issued by Govt.
    - c) Employee ESI registration certificate issued by Govt.
    - d) Turnover of the firm for the financial year 2017-18 alongwith certified copy of audited document by bonafide CA (Chartered Accountant) supported by ITR and Form-16 including Profit & Loss Statement.
    - e) Copy of ISO Certification, if available.
    - f) To provide experience certificates issued by the Govt. Institutions/Organisation/PSUs for **last three years i.e. 2016-17, 2017-18 & 2018-19** on Annexure-I as per the performa.
    - g) The contractor/agency must have a registration with the Contract Labour (Regulation and Abolition) Act, 1970. The contractor shall obtain the labour license under this Act.
    - h) Copy of PAN NO. & GST registration certificate issued by Govt.
    - i) Copy of Cancelled Cheque.
    - j) EMD of **Rs. 20,000/- (Rs. Twenty Thousands Only)** in the form of DD, FDR, banker's cheque or Bank Guarantee in F/o "The Director, ICAR- NBPGR, New Delhi"
