1. Candidates are requested to ensure their eligibility criteria of age, qualification etc. before appearing for the interview.
2. No TA/DA and official accommodation will be provided for appearing in the interview.
3. The post is purely temporary and will be filled on contractual basis initially for one year, which is extendable for two more years (on yearly basis) subject to the

requirement and satisfactory performance of the candidate.

4. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this Institute / any ICAR Institutes.
5. The candidates will have to fill the application form compulsorily (as per the format annexed). No objection certificate from the employer must be enclosed, in case, the applicant is in employment elsewhere. The selected candidate will have to produce all the original documents for verification and medical certificate at the time of joining.
