Sub: Five Yearly Assessment / Re-assessment of eligible Technical Personnel for the period ending 31.12.2014 submission of assessment forms in respect of Technical Category I, II and III.

Accordingly, a few sets of prescribed assessment forms are enclosed herewith which may please be handed over to the eligible employees only, for furnishing relevant information relating to the period for which they have to be assessed/re-assessed. It may please be ensured that assessment forms in respect of all Technical Personnel as are eligible on 31.12.2014 may please be furnished by 01.01/2015.

It is, further requested that the required information/assessment forms duly completed in all respect and reviewed by the reviewer in each case may kindly be sent to this office on or before O1.01.2015 positively for further necessary action in the matter. It may also be intimated that after expiry of the stipulated date, no request would be considered.
