

1. Fees for handling and processing of germplasm to be supplied through Material Transfer Agreement (MTA). All figures indicate charge per sample in Rupees

Note: In case the seeds of indented germplasm are supplied by an institution recognized by ICAR as a National Active Germplasm Site (NAGS) or any other ICAR institute, SAU/CAU, then the indenter shall pay the fees directly to the supplying institute on the advice of ICAR-NBPGR.

Importing agency must furnish DSIR certification.

### Notes:

- In the event of grant of relaxation by the Competent Authority (in respect of Phytosanitary Certificate and/ or Clause 9(2), the consignment will be released to the indenter after levying **five times the normal fee** [Plant Quarantine (Regulation of Import into India) Order, 2003 Chapter VI Clause 14(2)].
- In the event of the indenter not taking material after quarantine processing due to their own justified reasons and request for incineration by ICAR-NBPGR, **five times the normal processing fee** would be levied. In case they do not pay the required penalty, the indenting firm/ organization would not be allowed for further import till the existing dues are cleared.
